

## Electronic Prize Payments Incentive Promotion

### Terms & Conditions

1. **Acceptance of Terms and Conditions:** Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions.
2. **Type of Promotion:** This promotion is a -
  - (a) Promotional Game conducted pursuant to the *Charitable and Non-Profit Gaming Act 1999* (Qld)

**(Promoter)**

The Promoter and its related companies are referred to as the **Promoter Group**.
4. **Promotion Period:** Entry to the promotion is open 12.00 a.m. AEST on 1 August 2015 until 11.59:59 p.m. AEST on 31 August 2015.
5. **Eligibility:** Entry to the promotion is free.

5.1 Entry is open to:

- (a) residents of Queensland, New South Wales, Australian Capital Territory, Victoria, Northern Territory, Tasmania and South Australia who are 18 years of age or older; and
- (b) who are registered with the Promoter as a Winners Circle card/Players Club Card/Tatts Card/Easiplay Club card holder and whose card is current and active; or
- (c) who have a Product Account with the Promoter as defined in the Promoter Group's relevant terms and conditions associated with the operation of the person's Product Account; and
- (d) who provide, confirm or update their current email address, bank account details, mobile phone number or prize payment preference preferences with the Promoter during the Promotion Period.

**(Eligible Entries)**

All entries become the property of the Promoter.

Eligible entrants will receive one (1) entry into the promotion during the promotion period. A maximum of one (1) entry per player will be awarded during the promotion period.

The Promoter is not responsible for any problems or technical malfunction of any computer system, software or Internet difficulties, including any damage to an entrant's computer, resulting from participation in the promotion. 18. **Delay or modification to conduct of the promotion:** Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable of running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
19. **Privacy:** The Promoter Group is authorised to collect certain personal information for the purpose of entry into the Promotion under the provisions of legislation as set out in item 2 above.
