

Easiplay Club –“Monthly Bonus Draw” 1 July 2015 –31 December 2015 Promotion (Tatts Lotteries SA Pty Ltd)

Terms & Conditions

1. **Acceptance of Terms and Conditions:** Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions.
2. **Type of Promotion:** This promotion is a Promotional Lottery conducted pursuant to the *State Lotteries Act 1966* (SA) and the Lotteries (Promotional Lottery) Rules.
3. **Promoter:** The promoter is Tatts Lotteries SA Pty Ltd ACN 146 245 007 (Tatts SA) acting as master agent for the Lotteries Commission of South Australia of Level 1, 26 Franklin Street Adelaide, SA 5000, Australia phone 131868 (SA) (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
4. **Promotion Period:** The Promotion will be conducted on an individual monthly basis for the period commencing on 1 July 2015 to 31 December 2015 (inclusive) (**Promotion Period**).
5. **Promo Month:** Entry to the promotion is open from 12:00 am on the first day of each calendar month until 11:59:59 pm on the last day of each calendar month during the Promotion Period (**Promo Month**).
6. **Eligibility:** Entry to the promotion is free.
 - 6.1 Entry is open to:
 - (a) residents of South Australia who are 18 years of age or older; and
 - (b) who are registered with the Promoter as an Easiplay Club card holder and whose card is current and active; or
 - (c) who have a Tatts SA Product Account with Tatts SA as defined in the Promoter Group’s relevant terms and conditions which is linked to the entrant’s Easiplay Club card; and
 - (d) who use their Tatts SA Product Account or their Easiplay Club card to purchase a Saturday X Lotto, Monday & Wednesday X Lotto, Powerball, Oz Lotto, The Pools, Super 66 or Keno entry with the first draw taking place during the Promotion Period (**Eligible Entry**).
 - 6.2 The following people are not eligible to enter this promotion or win any prizes resulting from this promotion:
 - (e) employees of the Promoter Group who are directly involved with the conduct of any of the monthly draws for this promotion; and/or
 - (f) an entrant whose Easiplay Club card is either deactivated due to a Responsible Gambling concern or inactive for another reason.
7. **How to enter:** The Promoter will automatically enter you into the monthly draw in the relevant Promo Month each time you register an Eligible Entry to your Easiplay Club card.

8. **Number of entries:** The number of entries you will receive and the monthly bonus draw which you will be entered, is as follows:
 - (a) For an Eligible Entry which is not a multiweek entry, you will receive one entry in the relevant Promo Month for each \$1.00 (or part thereof) of the value of the Eligible Entry.
 - (b) For an Eligible Entry which is a multi-week entry, the value of the entry will be the total value of the Eligible Entry. You will then receive one entry in the relevant Promo Month for each \$1.00 (or part thereof) of the total value of the Eligible Entry.
 - (c) If an entrant cancels their Eligible Entry, their entry/s into the monthly bonus draw may be cancelled in relation to that Eligible Entry.
 - (d) From time to time and as advertised by the Promoter, special bonus entries may be provided for certain Eligible Entries.
9. **Prizes:** The prizes for the Promotion are 4 prizes of \$5,000 each to be won in each Promo Month during the Promotion Period.
10. **Conduct of the draw:** The winning entries for each Promo Month during the Promotion Period will be drawn randomly by computer, at 11:00am on the second Monday of the following month at 87 Ipswich Road, Woolloongabba, Queensland, 4102. If this is a public holiday, it will be drawn on the next business day at the same time.
11. **Prize winners:** The first four valid entries drawn for each Promo Month will win the applicable prize for that month, subject to that entrant: (1), producing to the Promoter if requested photo identification or other identification acceptable to the Promoter which confirms that the entrant is over 18 years of age; and (2), completing a statutory declaration signed by a Justice of the Peace confirming details about the entrant and their entry. The Promoter's decision as to the result of each monthly draw is final and no correspondence will be entered into.
12. **Notification to prize winners:** The prize winners for each Promo Month will be notified by phone, mail, email or other means of electronic communication as soon as practicable after the relevant monthly draw. The Promoter may also announce or publish the initials and suburb or town of the prize winner in any media, including the Promoter's website.
13. **Delivery of Prizes:** The prizes for each Promo Month will be payable by cheque (or by electronic funds transfer if agreed with the prize winner) to the name/s of the winning registered player/s in the Easiplay Club membership register.
14. **No right to transfer prize:** The right to a prize is not transferable or assignable to another person.
15. **Unclaimed Prize Draw:** If a prize winner is unable to be contacted within 3 months after the date of the relevant monthly draw then that person's right to the prize is forfeited and the prize will be entered into an unclaimed prize draw. The Promoter may conduct such further draws at the same place as the original draw as are necessary 3 months after the date of the original draw at midday in order to distribute any unclaimed prizes, as determined by the Promoter in its absolute discretion, subject to any directions given by a responsible authority under any relevant regulation.
16. **Validity of entries:** The Promoter reserves the right, at any time, to verify the validity of an entry or disqualify any entrant who submits an entry that is not in accordance with these

terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.

17. **Computer system issues:** No responsibility is accepted for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or Internet difficulties, including any damage to an entrant's computer, resulting from participation in the promotion. Any cost associated with accessing or submitting an entry is the entrant's responsibility.
18. **Liability:** The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
19. **Force Majeure:** If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. "**Force Majeure**" means an event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.
20. **Delay or modification to conduct of the promotion:** Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay, modify or cancel any aspect of this promotion if for any reason it is not capable of running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
21. **Privacy:** The Promoter Group is authorised to collect certain personal information for the purpose of entry into the promotion under the Lotteries (Promotional Lottery) Rules. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use the personal information collected about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents (which may include disclosure to financial institutions, lawyers, auditors, IT service providers, mail service providers, marketing service providers, market research companies, selling agents) and gaming and other regulators, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information about products and services of the Promoter Group. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.
22. **Failure to provide personal information:** If an entrant does not provide the personal information requested, the entrant cannot participate in the promotion and will not receive information about products and services of the Promoter Group.
