TERMS AND CONDITIONS

- Acceptance of Terms and Conditions:** Instructions and information on how to enter the promotion form part of these terms and conditions. The purchase of three \$2.20 Super Jackpot entries during the promotion is deemed acceptance of these terms and conditions.
- Promoter:** The promoter is New South Wales Lotteries Corporation Pty Ltd (ACN 142 890 195) of 1 Figtree Drive, Sydney Olympic Park NSW 2127, phone 131 868 (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
- Participating Outlets:** This promotion will be available from all NSW Lotteries retail outlets (**Outlets**) and online through www.tatts.com/nswlotteries. Entries purchased through resellers are excluded from this promotion.
- Promotion Period:** Entry to the promotion is open from 00.00.01 on 31 March 2016 until 11.59.59 on 2 April 2016 (**Promotion Period**).
- Eligibility:** Entry into the promotion is free and open to New South Wales and the Australian Capital Territory residents aged 18 years of age or older.
- How to qualify:** To qualify for this promotion a player must purchase three Lucky Lotteries Super Jackpot numbers in the same open draw in the one transaction from any New South Wales Lotteries retail outlets or online through www.tatts.com/nswlotteries during the Promotion Period (**Qualifying Transaction**).

Redeeming Super Jackpot Free Tickets does not constitute “purchasing” a number in a draw for the purposes of this promotion.
- Complimentary ticket:** Each player who makes a Qualifying Transaction will be issued with one complimentary Lucky Lotteries Super Jackpot number (valued at \$2.20) that is valid for the current or next open draw (**Complimentary Ticket**).
- Restrictions:**
 - 8.1. There is no limit on the number of Qualifying Transactions that may be purchased during the Promotion Period to receive a Complimentary Ticket, subject to the Lotteries (Lucky Lotteries) Rules.

"Force Majeure" means an event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.

12. **Delay or modification to conduct of the promotion:** The Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable of running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
